Driving License for light vehicle

1. Original and valid Driving License.
2. Original Passport of the applicant.
3. Copy of Driving license.
4. Copy of Passport and Civil ID of the applicant.
5. Sponsor Civil ID copy in the case of 20 Number Visa.

Fee: KD 6.250

Driving License for heavy vehicle

1. Original and valid Driving License.
2. Original Passport of the applicant.
3. Copy of Driving license.
4. In case the applicant asks for Heavy Driving License – there should be a Employment Contract letter from the company which should be duly attested by Kuwait Chamber of Commerce & Industry and Kuwait Ministry of Foreign Affairs.
5. Copy of Company's Registration License (Etamatokiya).
6. Copy of Passport and Civil ID of the applicant.
